How to Name Girl Scouts as a Beneficiary in Your Will or Estate Plan  
We recommend consulting with your attorney or financial advisor to amend your existing will or trust, or establish a new one.

### You may find this sample language helpful:

Girl Scouts of Suffolk County is to receive the sum of \$\_\_\_\_\_and/or\_\_\_\_\_percent of the rest, residue and remainder of my estate. This bequest is unrestricted, and the board or other governing body may use and expend the bequest in any manner it deems appropriate.

You can also name Girl Scouts of Suffolk County as a full or partial beneficiary to a life insurance policy or retirement account. Please contact us to learn about other planned giving options.
