1. Girl Scouts of Suffolk County offers tuition assistance for summer camp on the following sliding scale based upon income.
2. Complete every field on this form. Make sure you include a phone number where you can be reached and a current e-mail address.
3. **You are required to submit proof of income with this form.** Proof of income is your 2023 federal or state income tax return. Do not submit your 2024 tax forms. If you were not required to file a federal or New York State income tax return for 2023, complete the Proof of Income Worksheet at the end of the application and submit it with this form.
4. Girl Scouts of Suffolk County reserves the discretion to award assistance to applicants that will not qualify under the income guidelines set forth herein if they demonstrate a unique need for assistance. If you believe your circumstances fit within this description, please complete the Request For Assistance - Extenuating Circumstances Form at the end of the application and submit it with this form.
5. If you are approved for assistance, you are responsible for the balance of the 2025 Summer Camp Tuition applicable to your camper(s) after the assistance is applied.
